### **SEPTEMBER 2020**

The recent email from our ODG officers has indicated that work is in progress with the CCCBR having discussions with PHE about further steps which may lead to some relaxation of the current restrictions that apply to ringing so perhaps a tiny glimmer at the end of the tunnel. In the meantime here are some updates on what is happening in the Chipping Norton Branch.

#### Burford

Unfortunately we are not in a position to make progress.

I measured the distances between ropes in the ringing rooms, and at the 6 bell towers none of them have 3 bells which are safely distanced. So that rules out Taynton, Fulbrook, and Asthall – and also Windrush where we are asked to help out. I have suggested to churchwardens that they might ring the Sanctus bell at their towers if they are having any services, and they agree with that suggestion. At Burford we could ring 3 or perhaps 4 bells from a safe distancing point of view of the ropes, but there are other issues concerning safe access and egress. In addition, most of our ringers do not live in Burford and I do not believe that it would right to expect ringers to spend time travelling (plus climbing 72 steps and ringing up and down) in order to ring for 15 minutes. Also, the churchwardens and clergy at Burford do not want us to ring: there are strict limits on numbers of the congregation, which would normally be much exceeded, so that they would not want any bells to be rung as that might attract extra people who would have to be turned away.

An important, even critical, additional factor for all our potential ringing is that: Nine of our ringers are over seventy years of age, including seven over the age of eighty. Some of these and/or spouses also have medical conditions, which make them even more vulnerable to Coronavirus.

I believe that we owe a duty of care to ringers and their families to avoid wherever possible any exposure to the virus, and it is far from clear how effective social distancing and other precautions are, particularly now that many lockdown restrictions are being relaxed, and schools reopening.

I believe that it would be premature to recommence bell ringing in the Benefice at this time. The priority must surely be to keep safe.

### Charlbury

As everywhere else, we are unable to ring at the moment - the ropes are too close together. We could ring three only, but decided that would sound too mournful. As an alternative we have dusted off the handbells and now welcome the congregation to the morning service while standing in a socially distanced circle in the churchyard. We also practise on Wednesday evenings at 4:30, when the church closes, and volunteer to clean the church with sterilised wipes when finished. So far we have learned several 8 bell calls - apart from Queens and Tittums, we've tried Whittingtons, Burdette, Hagdyke, Princes and See-Saw. They all sound lovely on handbells and we have had many compliments. We've not attempted hunting yet, but if this goes on for longer who knows what we might do. Another advantage is that the learners can contribute without having to go through the tedious process of learning bell handling. When we do go back, we're not sure how we will manage big bells - all our ringing muscles seem to have shrunk!

We are lucky we can open at Charlbury that, having only chairs, we can distribute them 2m apart and services have been well attended – I think we can cater for around 60 seats which are well filled each week.
